<u>Discussion Only regarding phone call from Rachel Loper in reference to an Artisan Well on her son's property located on Caldwell Rd between Silo and Durant:</u> Manager Clinton informed the Board of the phone call from Mrs. Loper. Field Superintendent Pearce informed the Board that he has spoken with Engineer, Jason Henderson, about this and Jason does not feel that 3,000 gpd will be of any use to us.

Manager Clinton and Field Superintendent Pearce informed the Board of the email from Fire Marshal, Brandon Brooks, requesting that the district provide a letter stating that they will be able to provide a minimum of 1000gpm for fire protection (See Attach #9). Field Superintendent Pearce stated that he had spoken with Engineer Henderson and he refuses to sign off on a letter like this, because due to the growth in our system, we would not be able to provide the customers in the western part of the district with the 25 psi required by DEQ. After we finish the plant upgrade and line upgrade on the Choctaw Project, Engineer Henderson will re-evaluate. Fire Marshal Brookes is also asking that another engineer evaluate our system in this area to have another opinion. The board agrees that if the city is willing to pay to have another engineer, it will be fine. (See Attach #10 for Engineer Henderson's Evaluation).

Manager Clinton informed that she had received the Engagement Letter for the 2022/2023 Audit.
